### WHY ARE KIDS LEFT BEHIND SO OFTEN?

How Noah's Story Underscores the Importance of Safety Checks

All too often, we hear about a small child left behind in a locked vehicle. At The Button Law Firm, the heart-wrenching story of 5-year-old Noah\* resonates deeply with our team. It's a stark reminder of the type of negligence that is entirely preventable and distressingly common in daycare settings.

Noah's ordeal began like any other day when he was picked up from school and then negligently left unattended in the daycare van. The terror he must have experienced as he tried to escape the van, crying and hyperventilating, stresses a grave lapse in care that should never have occurred. While he was able to exit the van, he remained stuck in the closed parking garage located across the street from the daycare until a good Samaritan found him. This incident wasn't just a momentary oversight; it reflected systemic failures within the daycare's operations.

Shockingly, this was not an isolated event. A similar situation occurred a year and a half earlier, showing that this daycare has a disturbing pattern of poor safety protocols and employee supervision. This repetition of carelessness proves this daycare ultimately failed its fundamental duty to ensure the safety of children.

Unfortunately, the emotional impact on Noah has been long-lasting. With new fears of being alone, recurring nightmares, and severe separation anxiety, this event has disrupted his daily life to such an extent that psychiatric intervention became necessary. It is a stark reminder of how deep the scars of trauma can run for children.

In representing Noah and his family, The Button Law Firm was driven not only to seek justice for the immediate failures but also to advocate for broader systemic changes to prevent similar incidents from ever happening again. We held the daycare accountable and ensured that rigorous safety protocols were enforced.

This case serves as a critical reminder for all parents to verify the safety practices of their children's daycare providers. A simple safety check can mean the difference between security and tragedy.

Russell Discusses a Harrowing Case on the 'Law&Crime' Podcast

Recently, Russell had the honor of speaking with Jesse Weber on the "Law&Crime Sidebar" podcast. This discussion wasn't about accolades or victories; it was a solemn opportunity to cast light on a grave issue that touches the lives of many families — daycare abuse.

The conversation centered around a harrowing case involving the Children's Courtyard daycare in South Austin, Texas, where unthinkable acts of abuse were captured on live surveillance, leaving families devastated and the community in shock. One of our clients, Mario Davalos, endured every parent's worst nightmare when he witnessed an employee mistreating his 2-month-old son through the daycare's live feed. The distressing footage showed the caregiver aggressively handling the child, including throwing and smothering, acts that no child should ever experience.

After the BLF team did our research, we soon learned that this incident was not isolated. The Children's Courtyard has faced **numerous** allegations and has a troubling history of violations that question its commitment to child safety. Despite these repeated warnings, severe lapses in safety protocols continued.

Our discussion on the podcast stressed the importance of vigilance and advocacy. As a law firm, our role extends beyond the courtroom. We are here to educate and empower parents and provide them with the knowledge and tools they need to protect their children. It's about ensuring no family has to endure such a traumatic experience ever again.
