BEWARE DAYCARE HORROR STORIES

Real-Life Cases That Are Haunting

As Halloween approaches, thinking of spooky stories and haunted tales is natural. But for many families, the real horror stories are the ones they never expected - the ones that happen at daycare centers. To make matters worse, the daycare didn't report the incident, and it wasn't until the child's mother noticed symptoms and took him to the hospital that the truth came out. When we got involved, we discovered the daycare had even tried to discard the broken chair in a dumpster to cover up their negligence.

Another case involved a child who was left in a hot daycare vehicle after being picked up from school. It was the middle of the day when temperatures were at their highest, and the daycare failed to do a proper

DON'T LET YOUR CHILD BE FORGOTTEN How Face-to-Name Checks Prevent Daycare Tragedies

We've seen a troubling rise in cases of children being lost amid the hustle and bustle of Texas daycare centers. Alarming, real-life cases include a toddler leaving the daycare unnoticed in Allen and even a 3-year-old girl wandering onto a busy highway in Nacogdoches. These incidents highlight a larger problem: **Some daycare centers are failing to follow essential safety procedures such as face-to-name checks.**

WHAT ARE FACE-TO-NAME CHECKS?

Face-to-name checking is a simple but vital procedure designed to ensure the safety of children in daycare. It involves a daycare worker calling out each child's name and matching it to the child's face, visually confirming the child is present. This practice should be done regularly throughout the day, particularly during critical transitions such as:

- Changing Classrooms: When children move from one classroom to another, face-to-name checks ensure the new teacher knows which children are now in their care.
- **Group Movements:** Whether moving children from the classroom to the playground or back again, face-to-name checks help ensure no child is left behind.
- **Field Trips:** These checks are essential during field trips to ensure all children are safe and accounted for throughout the outing.
- **Transportation:** When children are transported by van or bus, face-to-name checks should be conducted as they enter and exit the vehicle to prevent any child from being left behind.

WHAT ARE THE CONSEQUENCES OF NEGLECTING THESE CHECKS?

Children younger than five are particularly vulnerable when daycare centers do not perform face-to-name checks. Potential dangers include:

- Being Left in Vehicles: A child locked inside a daycare bus or van can guickly overheat, leading to heatstroke or even death.
- **Exposure to Harsh Elements:** A child left outside on a hot or cold day could suffer from hypothermia, heatstroke, or an asthma attack.
- Wandering Away: An unsupervised child could wander away from the daycare, potentially leading to unspeakable consequences.

HOW CAN DAYCARE CENTERS IMPROVE THEIR PROCEDURES?

These dangerous situations often arise because daycare centers cut corners, fail to train staff properly, or do not maintain the facility. When daycare centers neglect these basic safety protocols, the consequences can be life-threatening.

A quiet meal at a fast-food restaurant became a nightmare for our client, whom we'll call Jason. One moment, he was enjoying his meal, and the next, a car slammed through the restaurant walls, crashing into the area where he was sitting. The impact was so violent that it could have easily claimed Jason's life. Had he chosen a different table, just a few feet away, the outcome might have been tragically different.
